I was given a sheet of paper telling the teacher what the school wants them to use as identifiers. You had a choice of using EURBGS/EURBGS , SKWRAO/SKWRAO or SPHE*UT/SPHE*UT, you know, the name or first syllable of the last name twice. Now, I did teach it as mandated.

but I totally disagree with that method. That may work on a slow to moderate exchange when you are going from one speaker to another, but when it is a fast exchange with several speakers, the double stroking is going to fail. Using the arbitraries and striking them only once in my opinion is the best way to go. One of the teachers told me that their computers using CC has been programmed for the double stroke. My answer to that was to reenter it as one stroke. Seems pretty simple to me.

What I would like is for you to identify yourself, state the number of years you have been reporting, and then your credentials. I want you to state your honest opinion and why. I want you to do it respectfully because I want to have a discussion with the person that makes these decisions at the school and I would like to have her read your opinions as well.

Hi, Greg. This is Mary Ann Payonk in Washington, D.C. I went to school at Central Pennsylvania Business School in Summerdale, PA. I hold an Associates Degree in Specialized Business. I have passed the RPR, the RMR, the CRR, the RDR, the CBC and the CCP. I still consider myself holding a state certification in Delaware, even though a lawsuit by a large court reporting agency pounded that into the ground and did away with that. I do, however, hold a California license No. 13431, a Virginia membership, and notary appointments in several states.

I took my first job on June 6, 1977, so soon, I will have been reporting for 33 years. I learned a computer-compatible theory in reporting school. I've been a hard worker, I believe, working my way up to "heavy hitter" status when I worked for just one firm, then setting my sights on realtime. When I felt I had perfected my realtime writing to the point that I could sell the pleasure of viewing that writing for money, I left that firm and hung out my own shingle, eventually developed into a realtime specialty where I primarily and almost exclusively work for other reporting firms and rarely take on a client of my own. As a seasoned reporter with a realtime specialty, I don't use the artificial intelligence function of my CAT software, meaning if I write it wrong, it's just plain wrong and I take credit for that. But I also take credit for everything that's right, and I rarely write a job that translates below 99.9%.

Of course, I have no conflicts, and I edit extensively from the writer keyboard to ensure that my realtime output is as good as it possibly can be. That includes using macros, making new ones, and briefing on the fly. I've tried out the Auto Brief function of my Eclipse CAT software from time to time, but over the last 35 years, I've come to know that if my own brain doesn't think something up, well, it'll be hard for me to recall it when I need it again. Many times when I've found myself in a big biopharm or patent case, I've hit the stroke or strokes for a brief form for some very rarely used word or phrase and have been absolutely delighted to find that it was already in my dictionary from long enough ago that I'd forgotten it was there -- proof again that the better methodology of thinking up brief forms comes from my own head and not someone else's.

One goal that I've had for the last several years is simple: Write shorter. This, coming from a lifelong double-stroker. In school, we were given a SNOO/JOO choice and a double-stroke the name choice. I chose to double-stroke the name. When I embraced realtime writing about a dozen years ago, one of the first things I did was to delete every ADZ/ADZ = Mr. Adams, and JON/JON = Mr. Johnson entry from my dictionary. While I don't double-stroke individual names any longer, I do double-stroke my speaker identifiers, including EUFPLT/EUFPLT for THE COURT.

Here are my comments on your specific situation.

When the school mandates the strokes, or the type of strokes that a student must make, I don't think that's quite the best way to "write faster." Take it from a seasoned veteran when I say that NOW is the time, while students are still students, and learning

... NOW is the time to teach the very best method that will allow them to write like the wind. Ask any reporter who's tried to change the way they write after having been out in the working world for many years, and you'll find that it's not an easy thing to do once something is ingrained from the time of school.

I must say, the comment that the school's computers have been programmed for a double stroke is puzzling. Is it REALLY "My way or the highway" with them? I've heard some stories over the years about a certain caption company who would insist that reporters who worked for them wrote in a very certain and specific way ... and not only that, but they would check the reporter's notes, stand over their shoulder to make sure that the reporter was writing THEIR way. Sure, there's a method to that madness ... but there are also many very talented reporters out there who write conflict- and word boundary error-free just fine with their OWN methodology.

You commented that double-stroking is going to fail in a fast exchange. Interestingly, when I was in school, I passed my 180 takes in four-voice class. I use double-stroking speaker indications to this day, and it doesn't fail me. HOWEVER, the joy of having found strokes like MAEK for "making" and TAEK for "taking" could be trumped a thousand times if I could do away with the double-stroked entries I use for speaker identifications. That phrase, "seasoned veteran" also means "old dog," and even though I'm anxious and eager to learn new ways, some things, like double-stroking speaker IDs, is ingrained in me after 33 years of writing that way.

I wish I had learned and followed the single-stroke method of speaker IDs back in school. To each their own when deciding on how to write something, but the simple mantra of "Write shorter, write faster" simply can't fail ... in my humble opinion.

Hope this helps, Greg. You're doing great things by working with students!

My name is Janice McMoran, and I attended Fort Worth Court Reporting College in Fort Worth, Texas (no longer open). I began attending school in September 1980, graduated in November 1981, and certified in the state of Texas February 1982, so I have been reporting almost 28 years.

I have obtained my RPR, RMR, CRR, and RDR from NCRA and my BCRP designation from TCRA.

I learned the double-stroke method in school as well, but I quickly shortened it to one stroke for the main speakers. I use STPHAO for questioning attorney and SKWRAO for witness's attorney. I do use the double-stroke method for other attorneys in the room and KORT/KORT for the judge or hearing officer. I believe there may be a better way, though, but I simply have not incorporated that into my writing YET. I believe it is so easy to misstroke at least one of the strokes of the double-stroke, so that's why I believe a single-stroke method would be better.

Hi Greg

I've been reporting and retired after 40 years as an official. I originally learned the Berry Horne theory which was single-stroking. To become an official in NYS there is a NYS exam to take, I think it was 200 4-voice. It was an unrealistic exam because even 40 years ago they didn't speak that slowly. However, to your point, we were taught SNAO plaintiff's attorney; JAO defendant's attorney; EUFPLT The Court (or the Court, your preference) and EURBGS for any 3rd attorney or main speaker; full left bank (upper and lower) for Q; full right bank (upper and lower) for A. No double stroking. The theory behind it, and the repetitive drills, is "muscle memory", sort like reaching for the radio dial in your car at night without looking, your right hand knows exactly where to go.

You can extend the SNAO, JAO, EURBGS with additional keys for additional speakers (SNAO-D; SNAO -T ...) if need be. There's no need for double stroking.

I would also discourage the use of RED/RED for the attorney with the red tie, because tomorrow when the trial continues he may be wearing a blue tie.

Now, at a deposition if it is the standard two attorneys and the witness, I am going to be using STPHAO, EUFPLT, and W

If there are more, I then go to the SKWRAO, EURBGS.

If there is a special master, a judge sitting in, or an arbitrator, I use the court symbol to identify those people.

If I have big case going with a lot of attorneys, I can use the number bar with the comma. When I get to 7 on the number bar, I can switch to the

7 through 9 with the SKWR on the initial side. I now have 15 identifiers.

When you get in more than three voices in a deposition, you should make

a chart so you know what arbitrary is assigned to what voice.

Yes, the laws of physics will tell you your hands can only go up and down so many times in a minute. Are you going to waste that precious stroke to duplicate the previous stroke? I learned my theory in 1966. We were given an option of the arbitraries or the RED/RED. COURT/COURT was

never an option. It was as I explained above. Like I said, at a normal

pace, the RED/RED works just fine. When you get into a heated exchanges where there are offers of proof, rulings, requests to be further heard, ruling, request for record to be read, stroke to bring in the reading of the record, the witness coming in in colloquy. All of this is now happening at a pace that is almost beyond your abilities. But if you can save a half a dozen precious strokes and use those for the verbiage, that may be helpful. Think about when you practice and you are working on something that is very difficult to get down. You take a look at it and figure perhaps if I write STKWRET instead of SEUG/ER/ET or SEUG/RET and I write Irish REURB instead of I/REURB. After a few adjustments you

try it again, and now you can get it all down. All you really did was save a few precious strokes. It worked. That is how I see it.

Now in depos I use the initial side and vowels as an identifier of whoever noticed the deposition.

The final side and vowels are for the attorney who cross-examines

In court I always use the initial side for the plaintiff or prosecution and the final side for the defense.

I do that because the plaintiff or prosecutor is always at counsel table closest to the jury box, which puts them on my left-hand side as I look at them.

Now, we have had a couple distinguished members of our group express their opinions, and I am grateful for that. But you don't have to be an RDR to have an opinion. You can be a reporter in the trenches who has dealt with this topic and has an opinion. That is what I am looking for.

That is my method and my reasoning. If you disagree with me, let me know and tell me your reasoning.

Hi, Greg --

My name is Dee Dee Jones, and I am a couple of months away from having reported 20 years. I have an associate degree in court reporting from Alvin Community College (under the legendary Mary Knapp) and am licensed in Texas.

I mostly use all of the same identifiers you use, stroked once, except for EUFPLT and EURBGS. I also use many of the same ones Shelley uses such as the D-FRPBLGTS, J-FRPBLGTS (juvenile), M-FRPBLGTS (mother) when in court.

I, too, was taught to use the first syllable of their name stroked twice when there were more than two voices. I used this method for TOO MANY years!! I also frequently report for a committee that is roughly 45 attorneys, judges, etc., and I identify them with the beginning letter of their last name with the answer bank. So for Mr. Smith it would be S-FRPBLGTS, but if there were multiple names beginning with S, I just add another beginning sound or vowel with it (like Mr. Sampson would be SA-FRPBLGTS). For me it's easier to quickly recall the beginning sounds of their name and just throw it with the answer bank than trying to use the question bank. I had been using the W-FRPBLGTS for witness for a long time and it finally dawned on me to do that for this committee. :roll: Helped me keep my sanity!

Anyway, I wish that someone had suggested this method when I was in school. Good luck convincing the school! I'm Laurel Eiler, Florida native, court reporter of about 23 years (impossible). I'm an RDR and I may yet pass that CRR. It could happen.

I don't honestly recall if we were taught SNAO/JAO in school or double stroking. I just know I came out of school double stroking names. Here's the problems with that:

- 1. Two guys with the same name. I had one infamous case here in town with THREE Mr. Smiths (which will come out a cuss word starting with S and ending in T in a heartbeat) and TWO of them were Mr. D SMITH. In colloquy they had to be defined with their full names to avoid confusion. So I'd have had to revert to first names if I opted for double-stroking names.
- 2. Forgetting their name. Yeah. You lock up, you freak out and you freeze. Sure, you've got the seating diagram, but if you use the same defines over and over way less likely to happen. (I use SNAO/JAO/SNA/SNAOE for my four main and then branch out from there)
- 3. Stacking. Get going too fast and you stack the speaker designation and he gets "eaten" in colloguy or testimony that can confuse the crud out of you as you're trying to read back the question, answer, objection, etc.

so long story short, come up with at least four standards and define as Mr. Plaintff, Mr. lead Defense (and if you're lucky) Mr. 2nd Defendant and Mr. 3rd Defendant.

I've been reporting for 15 years, both as an official and freelancer. I use a slightly different system, but it works for me. 1234 is my questioning attorney and 6789 is opposing counsel. The Court is 1234-6789. The person who taught me this system used 1234-6, 1234-7, 1234-8 for additional attorneys. I could not wrap my brain around that so I instead use the first letter of a first or last name, whatever I can remember, with the answer bank. I reserve AO-ANSWER BANK for any anonymous attorneys that enter late, etc., and I need to get the name.

Otherwise I use similar designations:

G-ANSWERBANK = guardian ad litem R-ANSWERBANK = the reporterV-ANSWERBANK = the videographer I-ANSWERBANK = the interpreter JAO-ANSWERBANK = the juvenile officer

et cetera.

Why double stroke when you can do it in one?? My body hurts enough as it is. Save yourself some wear and tear!

My name is Jason Meadors. I've reported for about 33.5 years, last 30 years steno and previous 3.5 years voice.

In voice, which you probably don't care about, but still, we had to identify judge, trial counsel (prosecutor), and defense counsel. I reported them "jud," "try/try," and "def/def." If there was more than one counsel, I threw in their names. This was before voice

As a steno reporter, I was taught to double-stroke speaker identifications, and like M.A., I wish I could drop it like the bad habit it is. There's no reason that I can't do in one stroke what I do in two. So let me brief it to one stroke for you.

SNAO - prosecutor/plaintiff main counsel.

JAO - main defense counsel.

SGLAOIFRJTS - the Court.

If there's more than one prosecutor/plaintiff, I do STPHAO-F or -T or -N, whatever is intuitive to the person's name. (So if the second counsel is named "Yamato," I'll do SNAO-M.)

JAO-F or -R or -S or whatever is intuitive to the person's name, just the same as the plaintiff/pros counsel.

I do this in the fields for the case. When I come back on a second depo in the case, perhaps months later, I call up the fields to remind myself of who has what so that it translates nicely this time around.

I do the answer IFRJTS, and I double-stroke that for THE WITNESS. That double-stroke, I can't get away from.

It's also helpful to write a seating chart, with steno outlines noted, if there's a bunch of lawyers crowding in the room.

Hope that helps.

the last year of school and was introduced to the STPHAO method doing that, although I resisted it, thinking that the school surely had taught us a good way of identifying speakers.

Then I had a judicial fitness hearing with Mr. Hamilton and Mr. Hampton in the first couple of months out of school. I started using SKWRAO and EURBGS for first speaker, second speaker in a panic -- stroked only once. Later, I added STPHAO and EUFPLT for the next two, SKWRAOEURBGS for the fifth. After that, I fall back on double stroking names. It's rare I have that many.

I also learned WNS/WNS and KOERT/KOERT for witness and Court identifiers. I started using STKPWHRAO for The Court and EUFRPBLGTS for The Witness. I use W-FRPBLGTS when there is the hated scenario of a second witness sworn in, V-FRPBLGTS for The Videographer, SPW-FRPBLGTS for The Interpreter. All single strokes.

Besides the obvious advantages of speed and fewer opportunities for misstrokes using the single-stroke method, another is that once you have your arbitrary strokes set up, you can easily assign names to them before the proceedings start -- just plug them in, no need to create unique speaker symbols each job as is necessary using the syllable method.


